

URGENT ATT: The Office of the Prosecutor (OTP), Mr. Karim A. A. Kahn KC.

We are women and men in the Australian Defence Force in Enoggera (Gallipoli) Barracks in Queensland. The ADF order subordinates to torture Alex Edwards, a resident of Brisbane, Queensland, for 9 years and 9 months while international outrage continues.

We lack the power to do much more than request a remote hearing with the ICC take place IMMEDIATELY so that Alex Edwards' torture can be addressed by those who examine that Australia is a signatory to the Geneva Convention whereby torture is internationally illegal. It is also domestically illegal in Australia.

Our military law empowers us to employ Duty To Disobey illegal orders, and the order to torture is such an order, but, the chain of command prefer to place pressure on individuals and also encourage sycophantic and lawless individuals to perpetrate what is colloquially regarded by onlooking militaries (our allies and our supposed enemies) as the "worst torture in the history of our planet."

We provide two videos on this website of Alex Edwards addressing his phone camera, and Alex's expressions and screaming and references to Australian military holidays, for instance, provide the, we feel, reasonable and immediate perception that he has obviously been extremely tortured.

We place our confidence in the ambit of natural law to justify our declassification to you of the way in which this torture is taking place, being that our superiors are criminals in fact and we believe we could also perform a citizen's arrest upon them, considering the graveness of their criminal behaviour in real time.

The torture is performed with brain-sequencing computers.

Russia and China invented these computers decades ago and every brain on the planet is subjugated to programming and operations and control, but also augmentation and, yes, torture, however, every military we believe would testify that this is the worst torture they have ever witnessed, not just with this technology, but at all.

Alex Edwards is completely innocent, and the Australian Defence Force involves in its continuation of the folkloric torture behaviour of militaries a dubious pretext whereby it asserts that by torturing Alex Edwards with many militaries around the planet (all countries have brain-sequencing technology that can be operated instantly across the planet, just like a phone) that we will be able to assuage torture-fond adversaries in the Central Intelligence Agency and the United States Armed Forces who will be amused and pleased by our torture so much, that they will experience a forgetfulness that they are wanted as extraditions that the CIA and USAF allegedly will murder any person for attempting to effect. The reasoning is spurious to those who write this PDF document to you embedded in helpourmilitaryignoresthelaw.com. In reality, the CIA and USAF are consistently aware that they protect wanted criminals in the minds of oppositional cooperating militaries around the world and are not forgetful whatsoever due to the torture of Alex Edwards.

The CIA and USAF have watched for 9 years and 9 months while Russia, Canada, New Zealand, England, and many other countries exported their (as we described above) modern complacency with militaries and torture practices as if they were making a back room exhibition of incomparable human suffering for them to forget the unforgettable.

We seek to begin this conversation with you about how an ICC remote hearing (we are absolutely certain we will experience difficulty, due to the nature of the technology, traveling to The Netherlands) can take place.

We seek to prosecute The Australian Defence Force chain of command and also a programmer from the Russian Federation nicknamed “Wedge.” There are so many torturers and persons responsible for order giving to this abominable brain torture, hidden in plain sight in Brisbane and performed so much inside Alex Edwards’ mothers’ house under her nose and with her in the belief (wrongly) that he is schizophrenic. We prefer to draw a circle around the worst of the persons who have effected this grievous inhumane catastrophe on our planet to begin with, and then the conversation continues where we advocate for as much and full application of the international law to those persons who the authors of this document (and so many blood-curdling oppositional helpless voices around the planet who have been watching on for so long via the technology’s capacity to read suffering and provide video and more) regard as before Sub Jure the tribunal of as if Jesus Christ himself, however religions one might hitherto not be, the worst human beings who have ever lived in the history of sentience.

The People’s Liberation Army of China are cooperating with positive groups in the Australian Defence Force (who act in the aforementioned ambit, they are certain, of natural law) to program this document through Alex Edwards’s fingers right now! Without our collaboration to help you with brain-sequencing positively to be able to discover this website and PDF and embedded YouTube videos of torture, you would (we are quite confident of this!) **NEVER** receive the email or the phone call which would be wiped or cut by the Australian Security Intelligence Services and even other militaries who do this for them as part of AUKUS and Five Eyes (New Zealand, Canada, United States, Australia & The United Kingdom).

In other words, we have no way of submitting our request for a remote hearing in Australia with the ICC to via this PDF’s formal communications under Article 15 of the Rome Statute – without using the secretive technology to send you an audiovisual telegram in conjunction with sequence testimony. We understand that you have not granted consent, but you are free to “hang up the phone” once we begin speaking. Our fingers are crossed as decent similar aged men and women (Alex is 39) in Australia that you will hear our complaint with eagerness to the processing of this crime.

The torture is still being committed at 4:13PM UTC+10 18/09/2025, the time of this writing, but, we ask you to understand your legal powers connote a heroic lasso onto our dilemma as we stand up to older men and women who hate life and love and have divided our military in twain. The People’s Liberation Army of China are helping us do this, we repeat, and we are confident with their help we have enough “programmer power” (sequences are “programmed” to one head or another around the planet) to die forcing the law to collide with this humanitarian catastrophe **ONCE AND FOR ALL, AND AFTER SO LONG.**

Hear our cry!

Thank you for this correspondence that regards itself as the complainant's description that forms what we believe is, in conjunction with the videos embedded on this website, the basis for initiating a formal request for the ICC hearing to take place remotely upon these matters here discussed.
